48-hour advance notice is required for processing and approval.

SINGLE TRIP PERMIT FEE: Completing the table as contained herein is required to assess the legal weight per axle and/or axle group based on the *bridge weight formula* as found in South Dakota's Motor Carrier Handbook. Additional information is available at <https://oversize.io/regulations/axle-weight-calculator>. County staff will use the Legal Weight Calculator to compute your truck's legal load based on the configuration as entered on Page 2. The GROSS VEHICLE WEIGHT for the total number of axles of the load being permitted will be used to determine the pounds overweight by subtracting the GROSS VEHICLE WEIGHT from the legal weight. Then, using the distance traveled according to the route specified, the overweight fee cost will be calculated at the rate of \$0.50 per ton per mile. In addition, a standard permit cost fee of \$22.00 is added to the overweight fee to determine the Total Single Trip Permit Cost.

MULTIPLE TRIP FEE: This fee is similar to the Single Trip Permit Fee but the number of months is used instead of miles traveled based on a route. Months will not be pro-rated. The Pounds Overweight will be determined and then a rate of \$9.00 per ton overweight per month will be assessed in addition to the standard permit fee of \$22.00.

ANNUAL PERMIT FEE: This fee is similar to the Multiple Trip Fee but the rate per ton overweight per year fee is \$36 without consideration for the number of miles traveled or number of months or the route. A \$22.00 standard permit fee will be added.

OVERSIZE ONLY PERMIT FEE: \$22.00 single trip (\$66.00 annual). At no time does this permit allow any truck and/or trailer combination exceeding legal loads to be permitted without an approved Overweight Permit. All vertical and horizontal clearances shall be the responsibility of the permitted user. Damages to structures, signs, or other accoutrements within highway right-of-way shall be paid for by the permitted user.

OVERSIZE HAULS MAY REQUIRE COUNTY ESCORT—Must Call Jason at (605) 681-4701 at least 2 business days before move to schedule escort.

Summer Hours: M-Th 7:00am – 5:30pm; **Winter Hours:** M-F 7:30am – 4:00pm; Closed on all Holidays observed by Minnehaha County.

Cash, in-state personal check, business check, cashier's check, money order, or credit cards are acceptable. Extra fees may be added to credit card payments.
